The proposed tax rate is greater than the voter-approval tax rate but not greater than the de minimis rate. However, the proposed tax rate exceeds the rate that allows voters to petition for an election under Section 26.075, Tax Code.

If TCESD No. 11 adopts the proposed tax rate, the qualified voters of the TCESD No. 11 may petition the TCESD No. 11 to require an election to be held to determine whether to reduce the proposed tax rate. If a majority of the voters reject the proposed tax rate, the tax rate of the TCESD No. 11 will be the voter-approval tax rate of the TCESD No. 11.
